**Subject: Third Party Agencies for carrying out inspection/ audits related to City or Local Natural Gas Distribution (CGD) Networks, Natural Gas Pipelines (NGPL), Petroleum and Petroleum Products Pipelines (PPPL), Liquefied Natural Gas (LNG) Facilities, LPG Storage, Handling & Bottling Facilities and Petroleum Refineries and Gas Processing Plants**

Sir,

On the basis of your application for provisional empanelment on the subject, it has been decided to empanel M/s SafeNet Industrial Solutions LLP as an approved Third Party Agency as per the PNGRB (Third Party Conformity Assessment) Regulations, 2015 for carrying out inspections/audits related to City or Local Natural Gas Distribution (CGD) Networks, Natural Gas Pipelines (NGPL), Petroleum and Petroleum Products Pipelines (PPPL), Liquefied Natural Gas (LNG) Facilities, LPG Storage, Handling & Bottling Facilities and Petroleum Refineries and Gas Processing Plants under relevant PNGRB T4S Regulations for a period of one year from the date of this letter, subject to the following general terms and conditions:

1. The TPA shall submit to PNGRB, every year, details of work orders awarded/executed along with inspection fees/charges for each work order during the previous financial year not later than May 1<sup>st</sup> of the following financial year.
2. The TPA shall provide to PNGRB every year the details of changes in relevant manpower during the previous financial year not later than May 1<sup>st</sup> of the following financial year.
3. The TPA shall obtain accreditation under ISO-17020 or any other appropriate standard for the scope for which TPA has been approved.
4. In case of suspension / cancellation / withdrawal of accreditation under ISO-17020, the TPA shall immediately inform PNGRB.
5. The TPA shall submit to PNGRB a half-yearly status report of T4S audits being undertaken for compliance of PNGRB regulations.
6. The Board reserves the right to review the aforesaid empanelment at any time at its sole discretion, keeping in view the performance and quality of audits.
